DfG would like to notify you of an upcoming requirement, and by doing so it is keen to understand where the market stands in terms of the Charity's requirement below.

This Expression of Interest (EOI) seeks information relating to a project that will take place in three or possibly four phases starting in the 1st Quarter of 2025. The phases include demolition of an existing structure (1), site preparation and erection of a new c.180sqm single storey building that will be used as a puppy training facility (2). The refurbishment and internal rearrangements including fit out of existing buildings (3) and the refurbishment and upgrade of an existing bungalow to make it habitable (4). Phase 1 & 2 will be completed contiguously phase 3 and 4 will be subject to funding but the intent of DFG is that they follow on from the 1st two phases with the minimum of delay.

Please note the following general conditions:

- This EOI will help the Charity to refine its requirements.
- DfG reserve the right not to proceed with a direct award. Nothing shall constitute a commitment to ordering unless the Charity undertakes a direct award that results in the award of a Contract.
- Should a Contract be awarded following an evaluation of EOI and Written Proposal, the Potential Provider agrees to supply the Services in accordance with the Terms contained within the Statement of Requirements and Contract.
- Any and all costs associated with the production of such a response to an EOI must be borne by the Supplier. DfG will not contribute in any way to meeting production costs of any response.
- Information contained within this document is confidential and must not be revealed to any third party without prior written consent from the Charity.
- Buyers shall use the EOI responses to produce a Supplier shortlist.
- We expect that all responses to this EOI will be provided by Potential Providers in good faith to the best of their ability in the light of information available at the time of their response.
 - No information provided by a Potential Provider in response to this EOI will be carried forward, used or acknowledged in any way for the purpose of evaluating the Potential Provider, in any subsequent formal procurement process.

CURRENT SITUATION

Dogs for Good wish to employ a supplier that will create the buildings and infrastructure necessary to support the above aims while allowing the site to support and maintain its existing business outcomes. Dogs for Good require that the appearance of the new buildings and refurbishments is in keeping with the Brand Values of the Charity that deliver Value for Money and Best Practice to all its stakeholders. Potential suppliers are asked to give indicative budgets and programmes for all the phases of the works. While outline sketches and layouts will be made available to companies expressing an interest, the requirement is for design and build and they are reminded that this EOI process is not a request for quotation.
